

Application for Permission to Erect or Replace a Headstone and Surrounds at St Mary's Drumagarner

Family Name on Headstone:

Prior to the commencement of any structural work, sculptors must have written approval and have, when asked to provide copies of their relevant Health and Safety Risk Assessments and relevant Insurance Policy Documents, such as Public Liability and Employers Liability Insurance at £10,000,000.

Monumental Sculptors may carry out their works in at St Mary's Graveyard Drumagarner during the following times: - **Monday to Friday 8:00am to 5:00pm.**

All stone memorials must be placed on a solid foundation and fixed to BS 8415.

Memorial Dimensions for the extension are as follows: -

Maximum Height of Headstone (Inc. base/subbase) 1.2 Meters (48")

Maximum Width of Headstone on a Single Plot (Inc. base/subbase) 1.1 Meters (42"), Width of surrounds outside to outside 1.2 Meters (48") and Length of surround outside to outside 2.60 Meters (102") for the graveyard extension and 2.40 Meters (96") for the existing graveyard.

Maximum Width of Headstone on a Double Plot (Inc. base/subbase) 1.2 Meters (48"), Width of surrounds outside to outside 2.1 Meters (84") and Length of surround outside to outside 2.60 Meters (102") for the graveyard extension and 2.40 Meters (96") for the existing graveyard.

The gaps between surrounds of adjacent graves will not exceed 0.15 Meters (6"). In the graveyard extension, the gap between back-to-back headstones will be 0.30 Meters (12"). In the existing graveyard this gap will vary depending on the space available. These gaps must be concreted by the monumental masons or sculptors as part of their work in installing the surrounds and headstone.

The monumental masons / sculptors must also provide a detailed drawing of their proposed headstone as part of this permit.

When erecting a memorial or completing necessary remedial works, the monumental masons and sculptors must remove all debris from the graveyard immediately following completion of their daily work tasks. They must also make good any damage that they may cause to other graves, pathways, shrubbery or grass etc. at their own expense and to the satisfaction of the Parish.

The Parish will not allow the installation of memorials that fall outside these guidelines. The cost to the modification or the removal of the out of specification headstone and surrounds will be charged to the Custodian.
